### 1.0 INTRODUCTION

- 1.1 Ardent Consulting Engineers (ACE) has been appointed by Woodland Environmental (WE) to advise on transport/access matters relating to the upgrading and modernisation of the Cherry Lodge Golf Club, Biggin Hill.
- 1.2 This Revised Transport Statement (TS) has been prepared in support of the planning application for submission to the local planning and highway authority, the London Borough of Bromley (LBB).
- 1.3 In pre-application submission scoping discussions with LBB, Duncan Gray (highways officer) requested that the forecast changes in traffic flow related to the proposed golf club improvement works are identified. Following submission of the application further comments have been made by LBB requesting additional information.
- 1.4 The planning application is also supported by a Construction Traffic Management Statement (CTMS), again prepared by ACE, which has also been revised to address comments made by LBB.
- 1.5 Following this introduction, the remainder of this report is structured as follows:
  - Section 2.0 describes the existing situation;
  - Section 3.0 identifies the redevelopment proposals;
  - Section 4.0 sets out the existing golf club vehicle trip attraction and provides a forecast of past and future levels of trip attraction based on club membership data; and
  - **Section 5.0** provides a summary and sets out the conclusions.

### 2.0 EXISTING SITUATION

### **Site Location**

2.1 The site which forms the subject of this planning application is located on the eastern fringe of Biggin Hill, as shown at **Plate 1**.




Plate 1: Site Location

### **Site Access**

2.2 The site is accessed from Jail Lane, which runs on an east-west alignment to the immediate north of the site. Jail Lane varies in character along its length, it being a circa 7m wide urban single carriageway road with footways as it passes through residential development immediately east of the A233, and narrowing to a circa 4.3m wide semi-rural lane beyond this. The site access is taken from the semi-rural lane section.

### **Local Highway Network**

2.3 The A223 Main Road is a circa 7.3m wide single carriageway road that is subject to a 30mph speed limit.

### **Strategic Highway Network**

2.4 The A223 connects to the A1 at Bromley Common to the north and the A25 at Westerham to the south, both via priority 'T' junctions. The A25 connects to Junction 5 of the M25 near Sundridge. The M26 and A21 also connect with the M25 at this junction.

### 3.0 PLANNING APPLICATION SCHEME

- 3.1 The planning application scheme comprises the re-landscaping of the golf course, with the inclusion of mounding for the remodelling of the practice field and mounding between a selection of golf holes. In addition, a driving range with 12 bays is to be provided; this will not operate like a true stand-alone commercial "pay and play" facility and will not have netting or ball collection.
- 3.2 The proposed modifications would improve playing conditions and golf course standards for members and visiting golfers, and is intended to help retain members, levels having fallen in recent years due to competition from other courses in the area.
- 3.3 The existing site access from Jail Lane will be retained.
- 3.4 The existing informal on-site car parking areas will be retained and surfaced, and formalised to provide 93 marked-out spaces in addition to the existing 33 surfaced spaces. Disabled spaces will be surfaced in asphalt while the remainder could be surfaced in pea shingle.

### 4.0 TRIP ATTRACTION

4.1 The golf club currently attracts a number of vehicle trips in the weekday AM and PM peak hours and throughout the day. The trip attraction of the existing site is considered in this section alongside its forecast past and future trip attraction.

### **Existing Site**

4.2 Automatic Traffic Count (ATC) surveys were undertaken at the golf club access road for an 8-day period between Thursday 17<sup>th</sup> and Thursday 24<sup>th</sup> February 2011. The survey results are summarised in **Table 4.1** and the full survey results are included at **Appendix A**.

4.3 **Table 4.1** identifies that the golf club currently attracts up to around 230 two-way movements in the period 07:00 – 19:00, with 25 of these in the traditional network weekday AM peak hour (08:00 – 09:00) and 15 in the PM peak hour (17:00 – 18:00).

### **Golf Club Membership Data**

4.4 WE has provided past, current and predicted future club membership numbers to inform the assessment work. The data is summarised in **Table 4.2** and includes % change from the 2011 'base year'. We have been informed that the membership projections included in the original TS were incorrect, and the corrected data, as contained in the Design & Access Statement submitted with the planning application, is now provided at **Appendix B**.

4.5 **Table 4.2** identifies a steady decrease in membership from 2000 to 2011 in the face of competition from other courses in the area, a trend that is expected to continue until 2015, two years after the proposed re-modelling works would be completed. It is anticipated that membership numbers will increase to 2005 levels by 2020, but are not forecast to surpass historic 2000 levels. This is due to the course operating at capacity during peak times (weekends); this occurred frequently in 2000 when the membership was at its highest level recorded in recent years of 765.

- 4.6 The course capacity effectively caps membership since people are unable to play at times when they are able and want to for safety reasons (only so many people can be accommodated on the course at any time, and this will not change as a result of the proposed works). Those in full-time employment are obviously restricted as to when they can play and so will elect to join another club if they cannot play during their limited leisure time. The club would not accept member numbers in excess of around 800 for this reason.
- 4.7 It should be borne in mind that current guidance on Transport Assessments, prepared by the Departments for Transport and Communities & Local Government in 2007, recommends a future assessment year of five years after submission of a planning application (i.e. 2016 in this case) be considered.
- 4.8 **Table 4.3** provides a forecast of the historic and projected future traffic attraction of the golf club from the 2011 base year in both 2016 and 2020 by applying the expected % change in membership from **Table 4.2** to the surveyed vehicle trip attraction in **Table 4.1**.

4.9 **Table 4.3** identifies that the golf club would attract around 80 two-way vehicle movements less in the period 07:00 – 19:00, when comparing membership levels in 2000 with those forecast in 2020. It is also predicted to attract 8 two-way vehicle movements fewer in

the traditional network weekday AM peak hour and 5 fewer in the PM peak hour compared to 2000.

### **TRICS** comparison

- 4.10 However, as requested by LBB, a comparison has been undertaken using vehicle trip rates from the TRICS database v2011(b). Since the database does not provide sufficient details of whether or not courses also have driving ranges, we have used data for 18-hole private courses to derive an estimate of the likely level of trip attraction associated with the existing course. We have then used data for stand-alone driving ranges to derive the expected increase due to the provision of the facility.
- 4.11 We consider this to represent a robust approach since many people already visiting the course to play a round of golf will combine their visit with one to the driving range. It is intended that the primary purpose of the range will be to serve existing members as an existing practice facility and so help retain membership levels in the face of competition from other clubs in the area. It replaces an existing informal facility which can currently accommodate around 8 golfers at a time, for which we have made no allowance, which is also an onerous assumption. The proposed range is not intended to provide a stand-along commercial facility.
- 4.12 The trip rate data for the 18-hole course and driving range for weekdays, Saturdays and Sundays is set out in Appendix C, as is the total trip profile by each hour during each day associated with the combined uses. Table 4.4 provides a summary of trip attraction associated with the 18-hole course and the driving range during the weekday network peak hours and the weekend peaks, as well as by day.

- 4.13 **Table 4.4** shows that even on the basis of the robust assumption that the proposed driving range attracts only new trips and none are combined with existing trips to the 18-hole course, the predicted increase in weekday peak hour traffic is minimal at 2 movements in the morning, and 10 in the evening. The expected increase at weekends is larger, at up to 24 vehicle movements per hour on Saturdays and 16 on Sundays.
- 4.14 Using the trip rate data for the two elements to derive a profile of vehicle arrivals and departures during the day gives the following projected peak car parking accumulation, with a total of 126 formalised spaces: -
  - Weekday: 44 cars (35% occupancy);
  - Saturday: 59 cars (47% occupancy); and
  - Sunday: 50 cars (39% occupancy).

### 5.0 SUMMARY AND CONCLUSIONS

- 5.1 This Revised TS has been prepared to support a planning application for the proposed upgrading and modernisation of the Cherry Lodge Golf Club, Biggin Hill and provide additional information requested by LBB. This comprises remodelling of the existing course plus provision of a 12-bay driving range. The latter will not operate like a true stand-alone commercial "pay and play" facility and will not have netting or ball collection, and will replace an existing informal driving facility which can accommodate up to around 8 players at a time.
- 5.2 The existing golf club vehicle trip attraction has been surveyed and a forecast of past and future levels of trip attraction has been derived based on club membership data. Using this approach, it has been forecast that the golf club would attract around 80 two-way movements less in the period 07:00 19:00, when comparing membership levels in 2000 with those forecast in 2020. It is also predicted to attract 8 two-way vehicle movements less in the traditional network weekday AM peak hour and 5 less in the PM peak hour.
- 5.3 In addition, vehicle trip rates for both 18-hole golf courses and stand-alone driving ranges have been derived from the TRICS database to identify the increase in traffic which could be expected to result from the proposed development during the weekday network and weekend peak hours. This is a robust assessment given that it is intended that the driving range will cater mainly for existing members and that they will use it during an existing trip to the course. Even on this basis, the predicted increase in weekday peak hour traffic is minimal at 2 movements in the morning, and 10 in the evening, but larger at weekends, at up to 24 vehicle movements per hour on Saturdays and 16 on Sundays.

- 5.4 The total car parking provision, comprising 33 spaces which are already surfaced and marked out plus an area already used for parking which is to be surfaced and formalised to provide a further 93 marked out spaces, is adequate to accommodate the expected total peak accumulation based on the TRICS data for the 18-hole course and driving range.
- 5.5 In conclusion, it is considered that the proposed development should be permitted on transport grounds.

### LOSS ANALYSIS

### CASHFLOW DIFFICULTIES/ THREAT OF ADMINISTRATION AND LIQUIDATION

Through declining 5 and 7 day memberships, reduced day ticket visitors and a food and beverage business badly affect by reduced custom, Cherry Lodge Golf Club has been experiencing cashflow difficulties for some time. This has forced the club to make drastic budget cuts, which have affected other areas of the business. For instance, the golf course maintenance and management budget was reduced which has in turn compromised the quality of the golf course. This leads to dissatisfied members and poor feedback from day ticket visitors.

The club have therefore taken the decision to pursue a scheme of modernisation to the whole golf club from the golf course to the club house and car park. Existing facilities require modernisation and new facilities are required to increase revenue streams from club house rental, driving range ball fees and on a wider scale, increased membership subscriptions.

#### **MEMBERSHIP LOSS**

Due to the high competition in the vicinity coupled with the current economic downturn, the club is suffering from declining levels of membership. This has had knock on effects in terms of the quality of golf experience that the club can provide its customers and the clubs financial health.

The table below shows how membership peaked in 2000 with 765 members, but has steadily decreased to just 475 members in 2011. Without the proposed golf club modernisation improvements, membership is expected to remain at around 450-470 members. Golf club revenues have decreased between 50 and 55% since 2000, which is mostly attributed to membership numbers, but also failing membership prices due to price matching and economic awareness. Retail and food and beverage revenues have also been adversely affected. Revenue generated by the current membership and external revenues generated from societies and day tickets, are insufficient to cover the efficient running of the club and upkeep of the golf course to an acceptable standard.

The table shows predicted future membership numbers based on the modernisation development moving forward. The red line depicts the commencement of modernisation

works and the green line depicts cessation of modernisation works, which will then require a further 9 months of establishment before the final product can be used in its entirety. The golf club are therefore expecting to see a slight fall in membership numbers due to the disruption created by the modernisation works, however, once the facilities are open and fully functional in 2013, it is predicting a rise in membership by 55 members in the 2015 and 25 members each year thereafter, until a ceiling of 600 - 800 members in 2019/20
